- 1. Hereby Releases, Waives, Discharges and Covenants Not To Sue Spectacle Blue Circus Arts and/or each of its officers, employees and agents all for purposes herein referred to as Releasees, from liability to the Undersigned, his/her personal representatives, assigns, heirs and next of kin for all loss or damage and any claim or demands therefore, on account of injury to the person or property or resulting in death of the Undersigned, whether caused by the negligence of Releasees or otherwise while the Undersigned is upon the and/or a participant in Spectacle Blue Circus Arts classes; and,
- Hereby Agrees To Indemnify And Save And Hold Harmless the Releasees and each of them from any loss, liability, Damage or cost they may incur (1) due to the presence of any action of the Undersigned in or about Spectacle Blue Circus Arts and/or (2) due to the participation in Spectacle Blue Circus Arts classes whether caused by the negligence of the Releasees or otherwise.

The Undersigned expressly agrees that the foregoing Release, Waiver and Indemnity Agreement is intended to be as broad and inclusive as is permitted by the law of the province of Alberta and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

The Undersigned warrants the following statements are true and correct and understands that the Releasees have relied on them in entering into the foregoing Release, Waiver and Indemnity Agreement and in giving the Undersigned permission to enter the premises of Spectacle Blue Circus Arts and to participate in Spectacle Blue Circus Arts classes:

- 1. No oral representatives, statements or inducements apart from this written agreement have been made.
- 2. The Undersigned individually is fully aware of the risks and hazards inherent in entering upon the premises of Spectacle Blue Circus Arts or in participating in any events or classes held in or upon the premises of Spectacle Blue Circus Arts and hereby elects voluntarily to enter upon said premises, knowing the present condition and knowing that said condition may become more hazardous and dangerous during the time that the Undersigned or either of them are upon said premises. The Undersigned is fully aware that trapeze and circus stunts and all activities associated with participation in Spectacle Blue Circus Arts classes is a calculated risk sport and contains inherent risks and dangers (including serious injury and death), that no amount of care, caution, instruction, or expertise can eliminate. The participant knows and understands the scope, nature, and extent of the risks involved in the activities contemplated by this agreement. The Undersigned individually hereby voluntarily assumes all risks of loss, damage or injury that may be sustained by them, or any of them, any damage to any property of the Undersigned, or any of them while in or upon the premises of Spectacle Blue Circus Arts or a participant in Spectacle Blue Circus Arts classes.
- 3. That he/she gives consent to whatever medical care might be provided or available on the premises and Further agrees to conform and comply with all the rules and regulations of Spectacle Blue Circus Arts.
- 4. I hereby give Spectacle Blue Circus Arts permission to use images of me (including any motion picture or still photographs made by Spectacle Blue Circus Arts of my likeness, poses, acts and appearances or the sound records made by Spectacle Blue Circus Arts of my voice)("Images") for any purposes in connection with promoting Spectacle Blue Circus Arts and its activities (the "Purposes"), which may include advertising, promotion and marketing. Spectacle Blue Circus Arts may crop, alter or modify Images of me and combine such Images with other images, text, audio recordings and graphics without notifying me.
